Greetings,

The purpose of this notice is to request the participation of homeowners to serve on the seven-member Board of Directors. **Six (6) positions are up for election at this year's annual meeting, scheduled for October 22, 2024.** Some openings are due to expiring three-year terms and others are due to resignations before a full term was completed. In order to transition back to the normal situation where 2-3 directors are elected each year, three of the newly elected directors will serve for three-year terms, one for a two-year term, and two for one year terms. The assignments will occur after the new board convenes in a fair and objective process. More information on this will come later. However, if you would like to be on the Board, you must be willing to serve for three years.

Per the Bylaws, the Board of Directors conduct regularly scheduled meetings as they deem necessary on any business coming before the association. Between meetings, some tasks may be handled via email.

Interested homeowners are requested to complete and return the enclosed nomination form to be considered as a candidate for director. **Nomination forms must be received by CPVA Management no later than Monday, September 23, 2024.** Notice of the upcoming annual meeting will be mailed to all owners in October. The notice will contain a proxy listing all nominated candidates and a brief biographical sketch of each candidate in order that owners may vote via proxy.
